What is a bill of lading?

The word *bill* is the statement of charges for either products or services that were rendered by the supplier or service provider to the buyer.

Lading means the act of loading cargo into a vessel.

Therefore, combined, the **bill of lading** outlines the agreement between the shipper and the shipping line (or carrier). It includes all of the information regarding the goods that are going into the vessel.

The functions of a Bill of Lading are as follows:

- 1. <u>Receipt</u> It acts as a document of the receipt of the goods.
- 2. <u>Contract</u> It outlines the shipping method that will be used for the cargo and acts as evidence of the contract of carriage with the carrier.
- 3. <u>Title of goods</u> For a named consignee to take the delivery of the goods on the discharge port or on the final destination (depending on what has agreed on), they must surrender the original copy of a B/L.

Details usually found on a bill of lading



ltem	Details	
1: Shipper	Usually the freight forwarder or the factory.	
2: Consignee	The one who will receive the goods upon arriving at the destination / i.e. the one with the import license	
3: Notify Party	Usually the buyer, but may also be the consignee.	
4: Tracking Number	The tracking number and the date of the Bill of Lading/Air Waybill	
5: Voyage Details	Ship or flight information	
6: Cargo Details	Description, gross weight and volume, and any notes, container number and seal no.	
7: Contract Details	This section is where the document is signed-off by the issue for legality	

Limitations

- Not all countries have digitized bills of lading.
- Not all countries allow bills of lading to be scrutinized by the public.
- Some countries only allow searching and/or display / exporting of certain fields.
- Almost all government agencies charge a "lookup fee" / "search fee" to access their data.
- Many products are miscategorized i.e. appear under the wrong HS code. (20% 30%).
